

#### new companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)

A total of 38 companies were registered in Washington during the second quarter of 2012 (Apr 2012 - Jun 2012).





#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)

A total of 24 companies were dissolved in Washington during the second quarter of 2012 (Apr 2012 - Jun 2012).





#### net growth by half year















#### director age by half year





The percentage of directors over the age of 65 was 8.1% compared to the UK figure of 3.3%.


#### director age by quarter

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2012)
