



The highest total for a first half year in Watford occurred in 2007 when a total of 1,021 were formed.

# Quarterly Data (Q2 Apr-Jun 2012)


Q2 2012 saw a new record in company registrations in Watford when compared to any previous Q2.





#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)

A total of 209 companies were dissolved in Watford during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 37.5% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.



#### net growth by half year













#### director age by half year




