
The first half of 2012 was a record first half year for company registrations in Wednesbury when compared to any half year in history.


Q2 2012 saw a new record in company registrations in Wednesbury when compared to any previous Q2.

new companies by quarter







dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)








net growth by quarter



company share by half year







director age by half year






director age by quarter
