
The first half of 2011 was a record first half year for company registrations in Wembley when compared to any half year in history.

Q2 2011 saw a new record in company registrations in Wembley when compared to any previous Q2.


Q2 2011 was a record quarter for company registrations in Wembley when compared to any quarter in history.





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





net growth by half year






net growth by quarter



company share by half year







director age by half year





director gender by half year


