In the first half of 2011 a total of 130 companies were formed in West Bromwich. This figure is 20.4% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in West Bromwich occurred in 2011 when a total of 130 were formed.


Q2 2011 saw a new record in company registrations in West Bromwich when compared to any previous Q2.


new companies by quarter


Quarterly Data (Q2 Apr-Jun 2011)



net growth by half year







company share by half year







director age by half year






director age by quarter

director gender by half year


