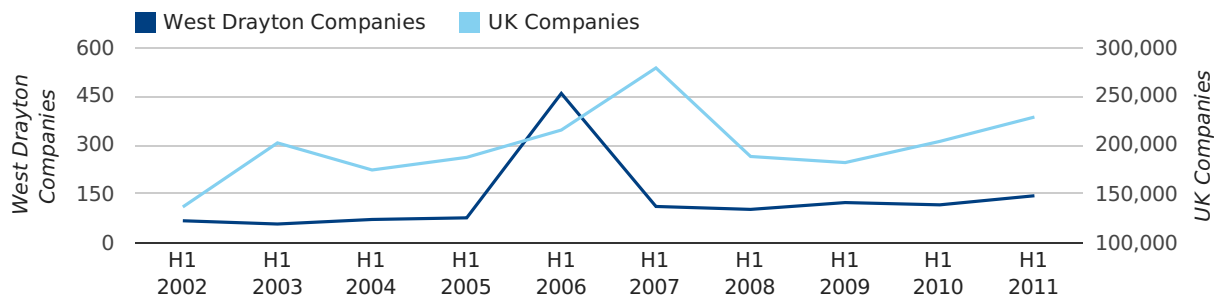
### Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 144 companies were formed in West Drayton. This figure is 24.1% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in West Drayton occurred in 2006 when a total of 459 were formed.

### new companies by half year



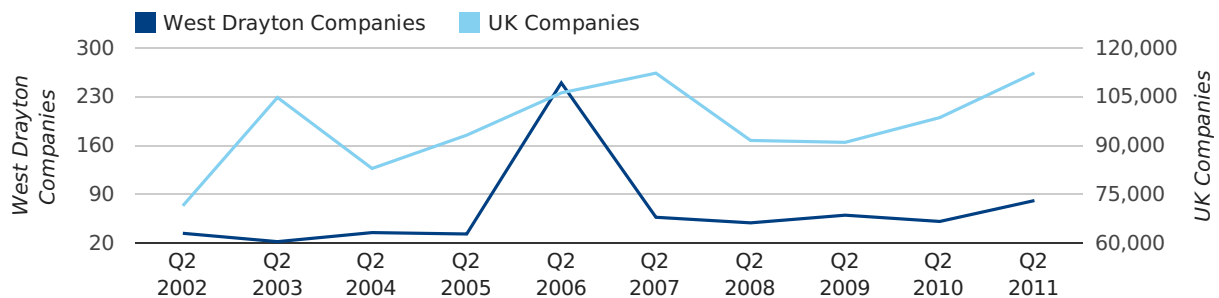
### Quarterly Data (Q2 Apr-Jun 2011)

A total of 81 companies were registered in West Drayton during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is an increase of 58.8% versus the same period last year (Q2 2010). This figure compares well to the UK as a whole, which saw an increase of 13.9% against the same period last year.

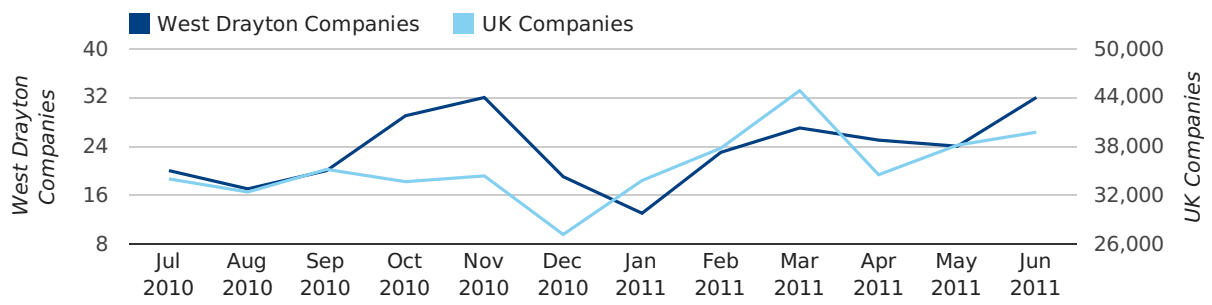

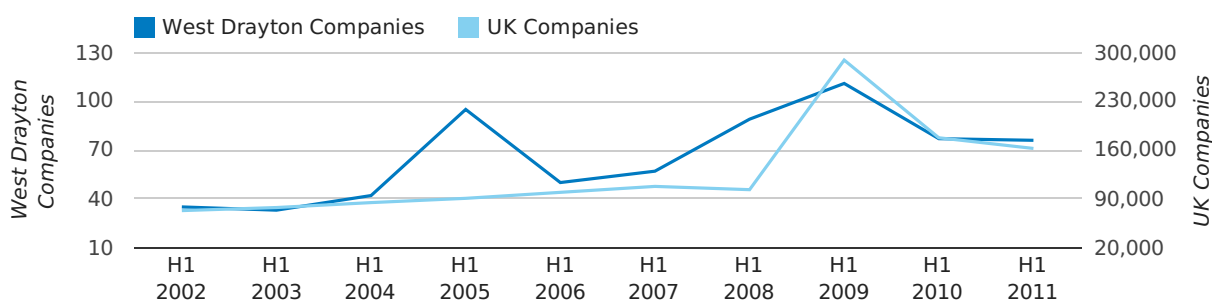
### Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 76 companies were dissolved in West Drayton. This figure is 1.3% lower than last year, which compares badly to the UK wide change of -8.6%.

The highest total for a first half year in West Drayton occurred in 2009 when a total of 111 were closed.

### dissolved companies by half year



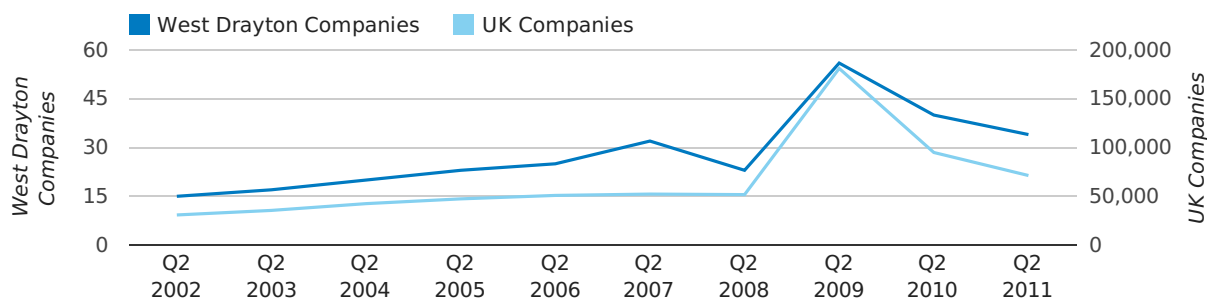
### Quarterly Data (Q2 Apr-Jun 2011)

A total of 34 companies were dissolved in West Drayton during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is a decrease of 15.0% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.

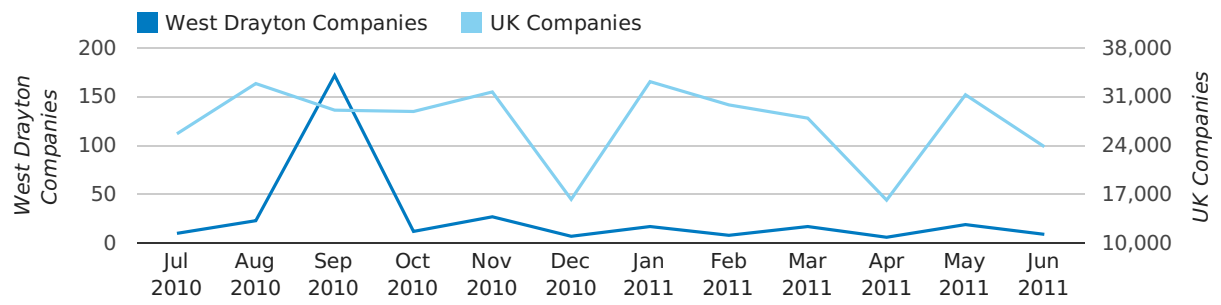

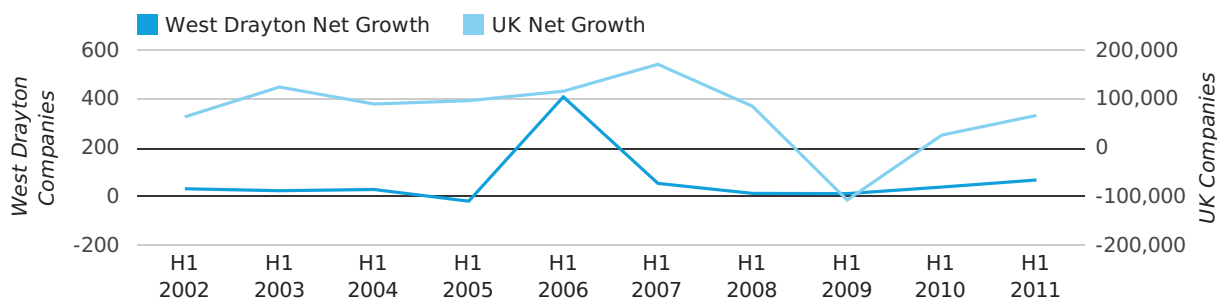

### net growth by half year



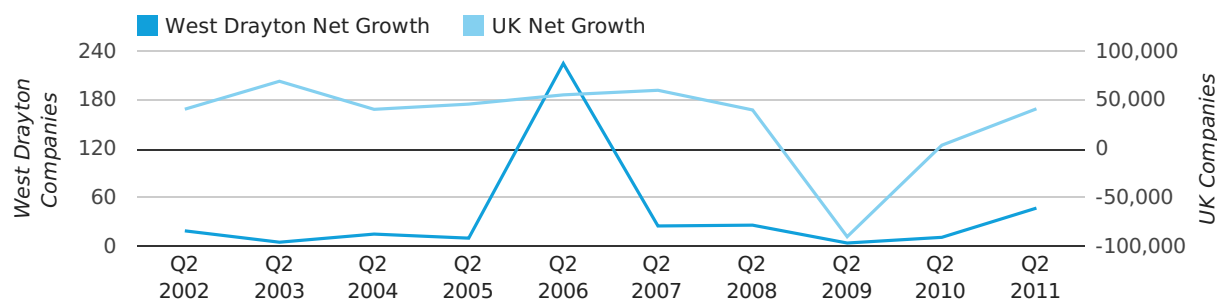
### Quarterly Data (Q2 Apr-Jun 2011)

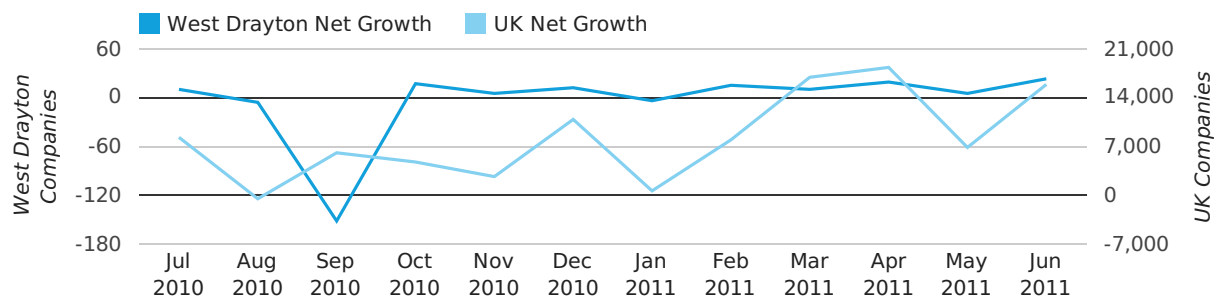
### net growth by quarter

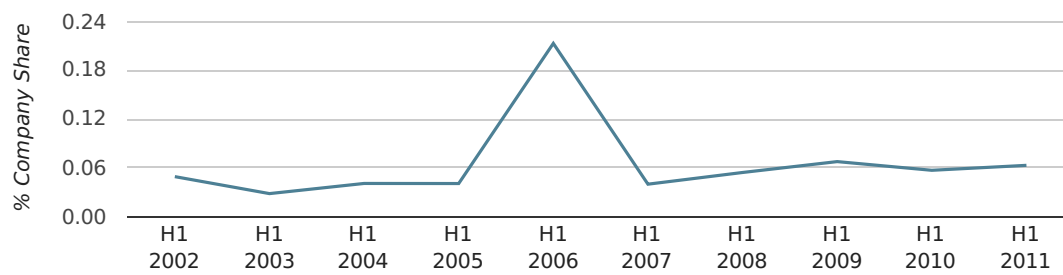

#### company share by half year

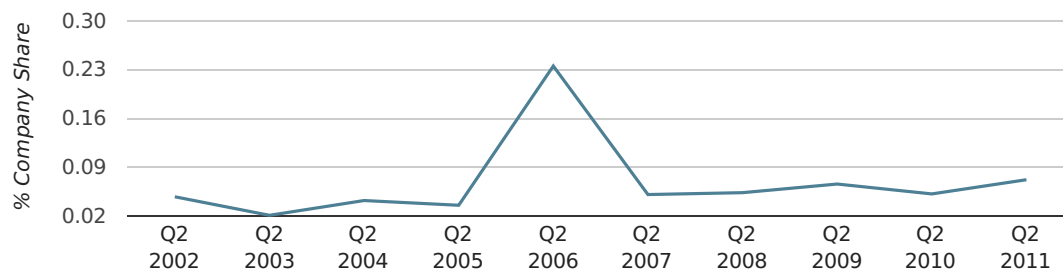

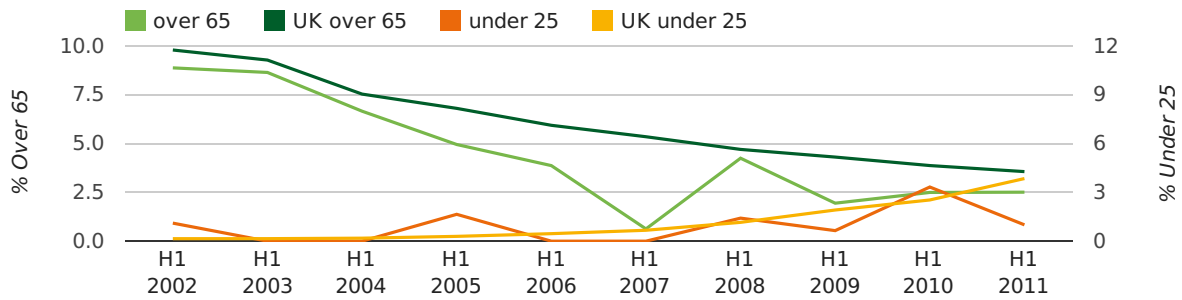

#### director age by half year



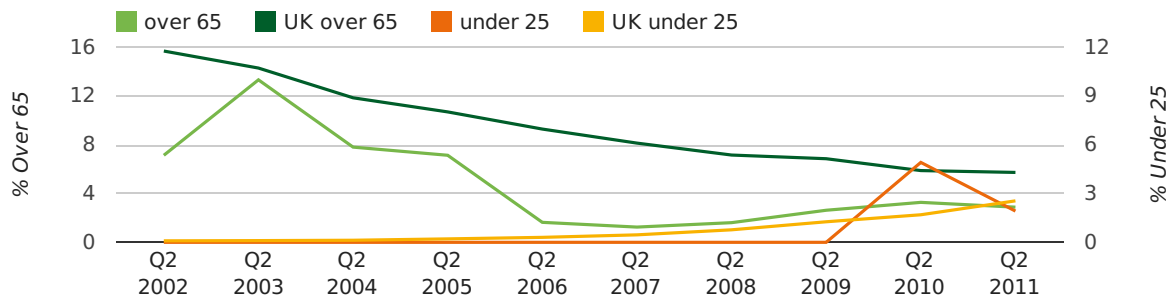

#### director age by quarter

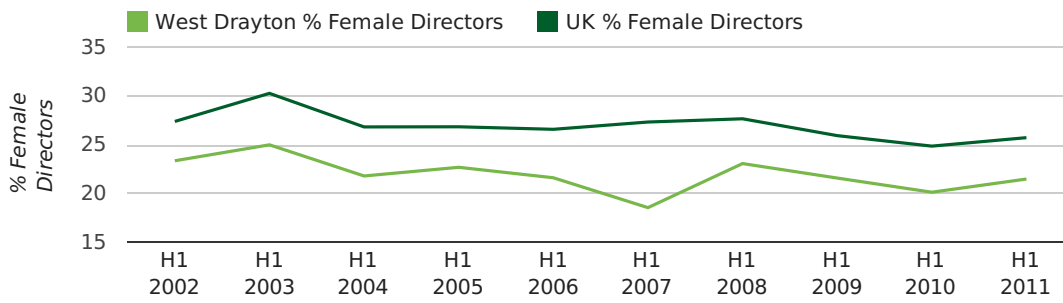


### Half Year Data (Jan-Jun 2011)

#### director gender by half year

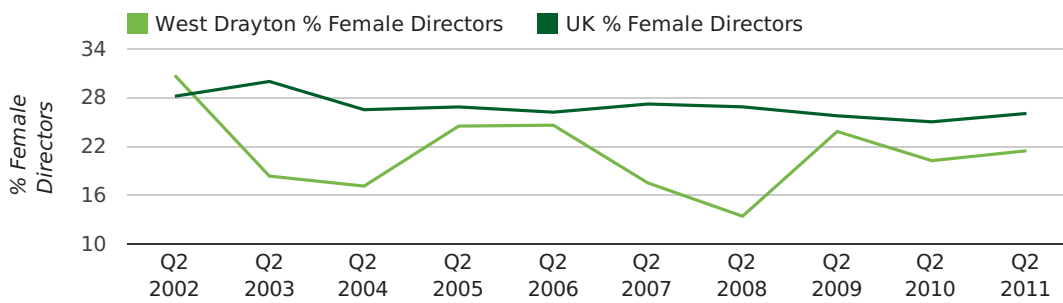


### Quarterly Data (Q2 Apr-Jun 2011)
