#### new companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)



#### dissolved companies by half year





A total of 852 companies were dissolved in West Sussex during the second quarter of 2012 (Apr 2012 - Jun 2012).





## net growth by half year













## director age by half year





The percentage of directors over the age of 65 was 5.1% compared to the UK figure of 3.3%.


#### director age by quarter
