


The second half of 2011 saw a new record in company registrations in Westerham when compared to any previous second half year.


new companies by half year





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 26 companies were dissolved in Westerham during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 75 companies were added to the company register for Westerham in 2011. This number represents growth of 46.6% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




net growth by quarter

net growth by month






company share by year







director age by year







