

A total of 392 companies were formed in Weston-Super-Mare in 2011. This total is 20.6% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Weston-Super-Mare when compared to any previous second half year.


Q4 2011 saw a new record in company registrations in Weston-Super-Mare when compared to any previous Q4.

new companies by quarter







dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Weston-Super-Mare when compared to any previous Q4.





net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Weston-Super-Mare during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 23 companies.



net growth by month






company share by half year





director age by year





director age by half year




director age by quarter

director gender by year



director gender by half year


