




Quarterly Data (Q2 Apr-Jun 2012)



dissolved companies by half year







net growth by quarter






company share by half year





director age by half year





The percentage of directors over the age of 65 was 4.4% compared to the UK figure of 3.3%.






The record first half year for female directors in Weston-Super-Mare was 1861 when 40.0% of all directors were female.
