




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 166 companies were formed in Weybridge. This figure is 10.8% lower than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Weybridge occurred in 2007 when a total of 207 were formed.




#### new companies by half year



dissolved companies by year




## Half Year Data (Jul-Dec 2011)

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Weybridge when compared to any previous Q4.




A total of 45 companies were added to the company register for Weybridge in 2011. This number represents growth of 12.1% which compares unfavourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)




Net company growth for Weybridge during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -1 companies.

#### net growth by quarter






company share by year







#### director age by year




#### director age by half year

#### director gender by year




## Half Year Data (Jul-Dec 2011)
