



A total of 79 companies were registered in Weymouth during the second quarter of 2011 (Apr 2011 - Jun 2011).





dissolved companies by half year





A total of 40 companies were dissolved in Weymouth during the second quarter of 2011 (Apr 2011 - Jun 2011).





net growth by half year







company share by half year







director age by half year






director age by quarter

director gender by half year


