




Half Year Data (Jul-Dec 2011)




new companies by half year



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 50 companies were dissolved in Weymouth during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 103 companies were added to the company register for Weymouth in 2011. This number represents growth of 37.2% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Weymouth during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 7 companies.

net growth by quarter






company share by year



company share by half year





director age by year




director age by half year

director age by quarter




