

#### new companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 79 companies were formed in Whitstable. This figure is 3.7% lower than last year, which compares badly to the UK wide figure of 14.0%.

#### new companies by half year




A total of 37 companies were registered in Whitstable during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





## dissolved companies by year




## Half Year Data (Jul-Dec 2011)

## dissolved companies by half year




A total of 27 companies were dissolved in Whitstable during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 61 companies were added to the company register for Whitstable in 2011. This number represents growth of 38.9% which compares favourably to the UK figure of 34.6%.




## Half Year Data (Jul-Dec 2011)

#### net growth by half year















#### director age by half year



#### director gender by year




# Half Year Data (Jul-Dec 2011)
