



A total of 94 companies were registered in Windsor during the second quarter of 2011 (Apr 2011 - Jun 2011).





A total of 72 companies were dissolved in Windsor during the second quarter of 2011 (Apr 2011 - Jun 2011).



dissolved companies by month



net growth by half year















director age by half year




