

2011 was a record year for company registrations in Windsor when compared to any year in history.

A total of 459 companies were formed in Windsor in 2011. This total is 12.8% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

## Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Windsor when compared to any previous second half year.

In the second half of 2011 a total of 228 companies were formed in Windsor. This figure is 4.6% higher than last year, which compares badly to the UK wide figure of 14.0%.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Windsor when compared to any previous Q4.



November 2011 saw a new record in company registrations in Windsor when compared to any previous November.





# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 140 companies were dissolved in Windsor. This figure is 14.1% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Windsor occurred in 2009 when a total of 178 were closed.

#### dissolved companies by half year




A total of 76 companies were dissolved in Windsor during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 160 companies were added to the company register for Windsor in 2011. This number represents growth of 39.3% which compares favourably to the UK figure of 34.6%.




## Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Windsor during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 39 companies.

#### net growth by quarter






company share by year



#### director age by year





## Half Year Data (Jul-Dec 2011)

The percentage of directors over the age of 65 was 2.8% compared to the UK figure of 4.1%.






The average age of a director in the fourth quarter of 2011 was 43.7.

#### director gender by year




# Half Year Data (Jul-Dec 2011)

The record second half year for female directors in Windsor was 1860 when 42.9% of all directors were female.

29.1% of all director appointments in Windsor in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.
