




Quarterly Data (Q2 Apr-Jun 2012)




new companies by quarter



dissolved companies by half year









net growth by half year





company share by half year







director age by half year



The percentage of directors under the age of 25 was 6.2% compared to the UK figure of 5.2%.


The percentage of directors over the age of 65 was 3.5% compared to the UK figure of 3.3%.

director gender by half year


