

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 127 companies were formed in Wisbech. This figure is 53.0% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Wisbech occurred in 2003 when a total of 150 were formed.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Wisbech when compared to any previous Q4.

This figure is an increase of 47.6% versus the same period last year (Q4 2010). This figure compares well to the UK as a whole, which saw an increase of 15.3% against the same period last year.


#### new companies by quarter



#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 62 companies were dissolved in Wisbech. This figure is 34.7% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Wisbech occurred in 2010 when a total of 95 were closed.

#### dissolved companies by half year




A total of 31 companies were dissolved in Wisbech during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### dissolved companies by quarter


A total of 110 companies were added to the company register for Wisbech in 2011. This number represents growth of 66.7% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Wisbech during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 31 companies.

This represents an increase of 520.0% on the same period last year.








#### company share by half year





#### director age by year




### Half Year Data (Jul-Dec 2011)

#### director age by half year




The average age of a director in the fourth quarter of 2011 was 44.5.

#### director gender by year




## Half Year Data (Jul-Dec 2011)
