
The first half of 2011 was a record first half year for company registrations in Woking when compared to any half year in history.

Q2 2011 saw a new record in company registrations in Woking when compared to any previous Q2.


Q2 2011 was a record quarter for company registrations in Woking when compared to any quarter in history.





dissolved companies by half year






A total of 148 companies were dissolved in Woking during the second quarter of 2011 (Apr 2011 - Jun 2011).









company share by half year



company share by quarter





director age by half year






30.8% of all director appointments in Woking in the first half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
