

The highest total for a first half year in Woking occurred in 2011 when a total of 1,295 were formed.




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 256 companies were registered in Woking during the second quarter of 2012 (Apr 2012 - Jun 2012).




The first half of 2012 was a record first half year for company closures in Woking when compared to any half year in history.

Q2 2012 saw a new record in company closures in Woking when compared to any previous Q2.


Q2 2012 was a record quarter for company closures in Woking when compared to any quarter in history.

## dissolved companies by quarter











company share by half year







### director age by half year





## Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 3.1% compared to the UK figure of 3.3%.






The record first half year for female directors in Woking was 1861 when 40.0% of all directors were female.

23.6% of all director appointments in Woking in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.


### director gender by half year
