




A total of 314 companies were registered in Wolverhampton during the second quarter of 2012 (Apr 2012 - Jun 2012).





A total of 228 companies were dissolved in Wolverhampton during the second quarter of 2012 (Apr 2012 - Jun 2012).










company share by half year





director age by half year






director age by quarter

director gender by half year


