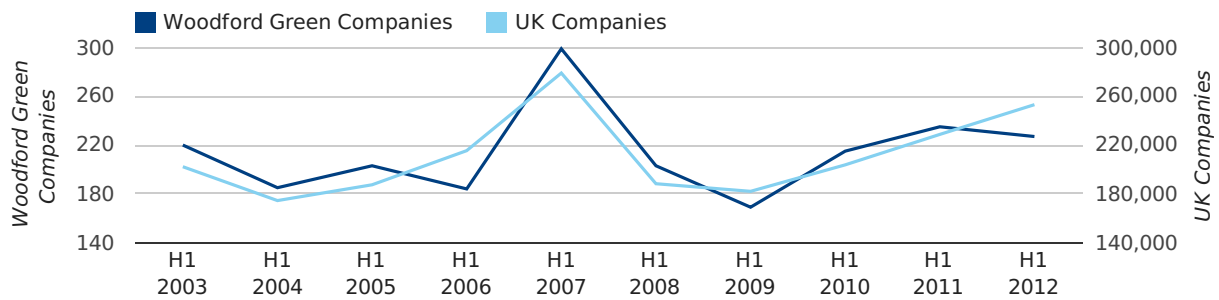
Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 227 companies were formed in Woodford Green. This figure is 3.4% lower than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Woodford Green occurred in 2007 when a total of 299 were formed.

new companies by half year



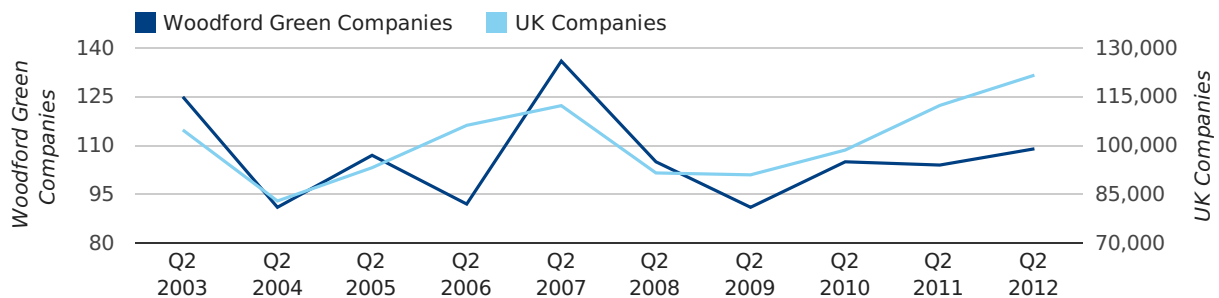
Quarterly Data (Q2 Apr-Jun 2012)

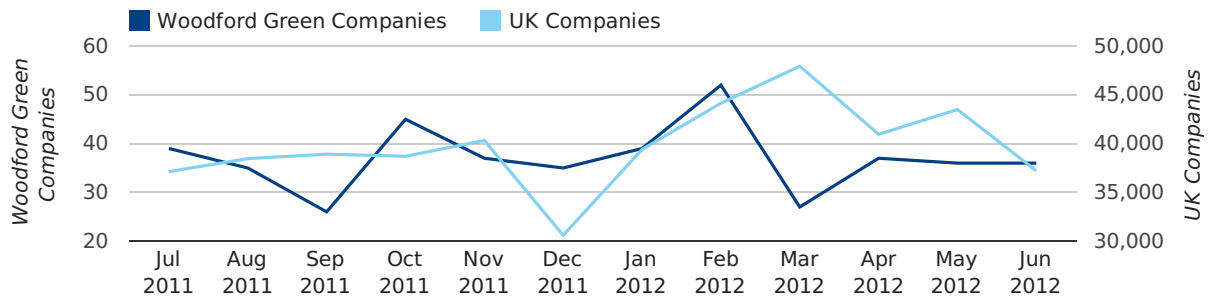

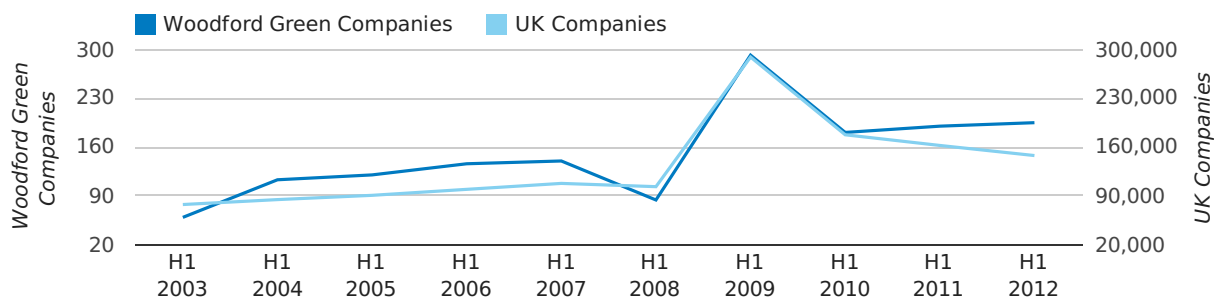
Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 195 companies were dissolved in Woodford Green. This figure is 2.6% higher than last year, which compares badly to the UK wide change of -8.9%.

The highest total for a first half year in Woodford Green occurred in 2009 when a total of 292 were closed.

dissolved companies by half year



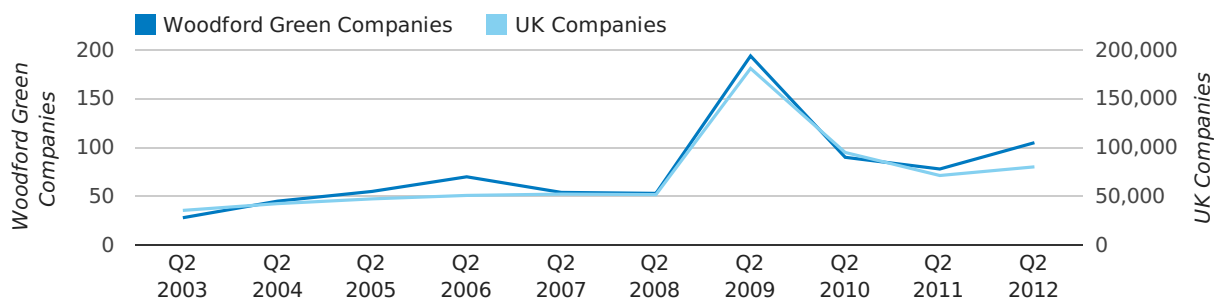
Quarterly Data (Q2 Apr-Jun 2012)

This figure is an increase of 34.6% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.

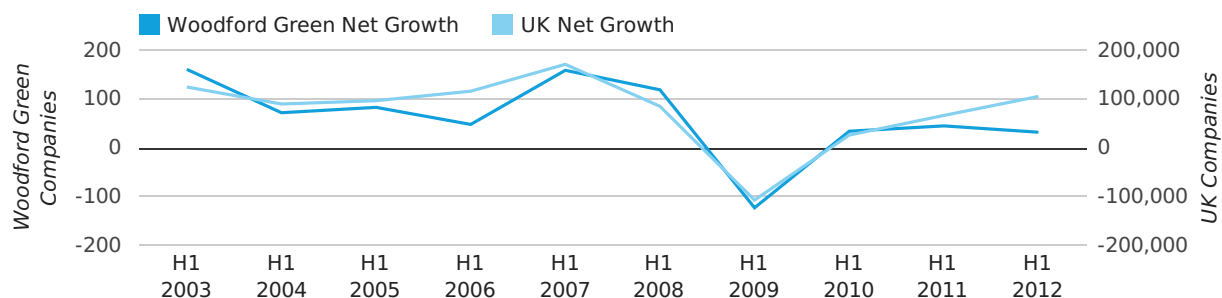

net growth by half year



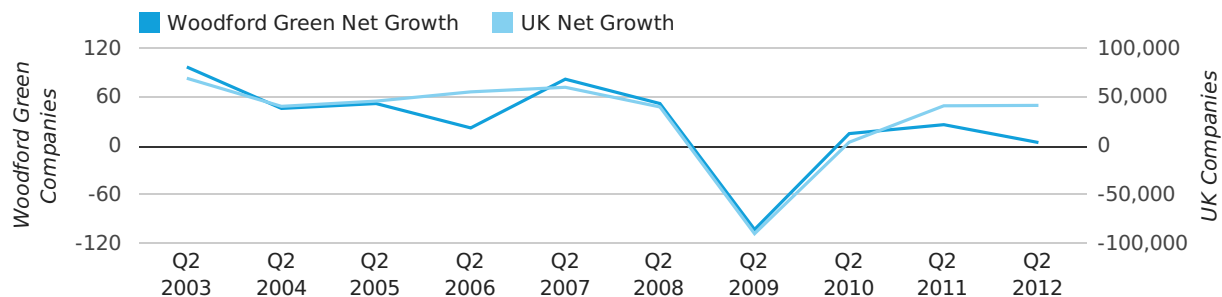
Quarterly Data (Q2 Apr-Jun 2012)

This represents a decrease of 84.6% on the same period last year.

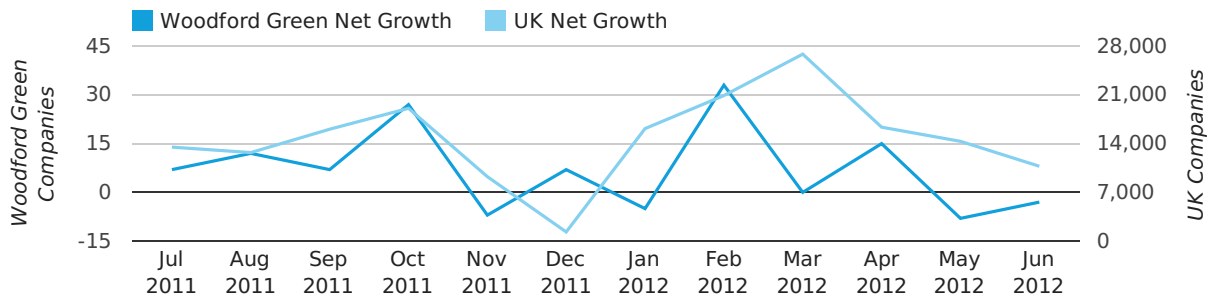

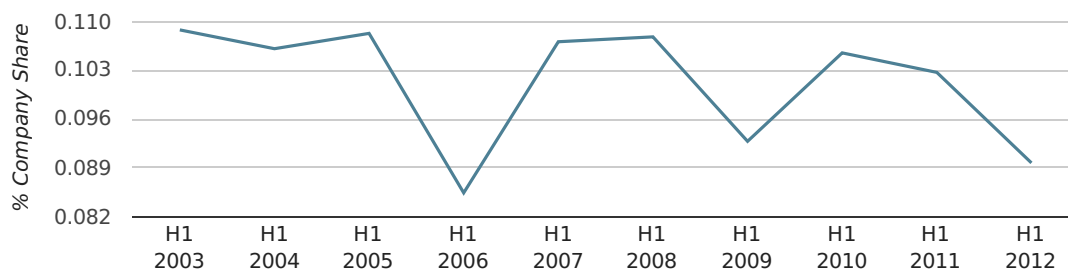

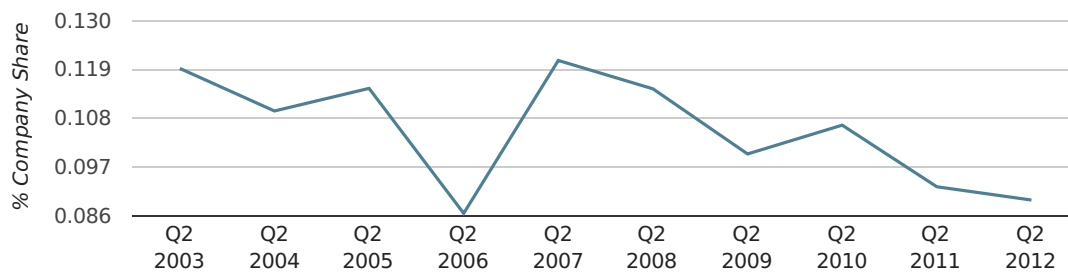

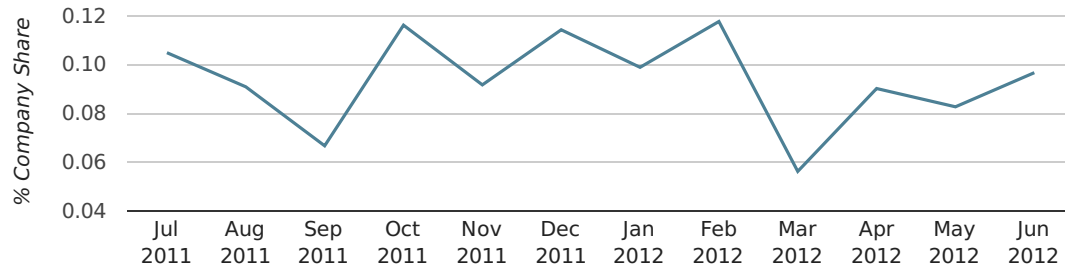

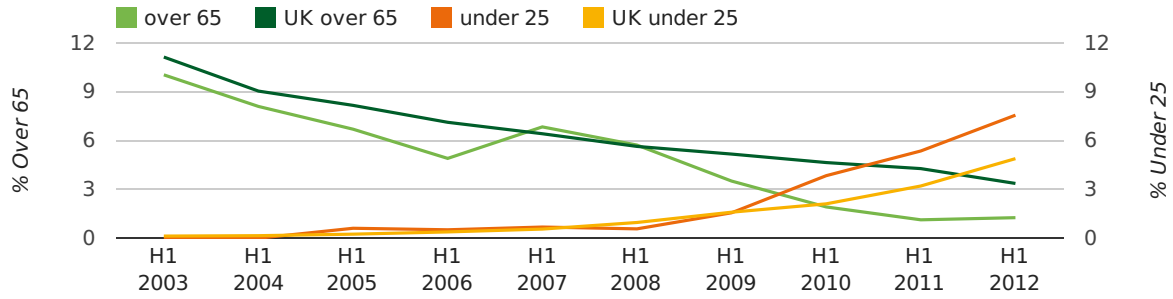

director age by half year



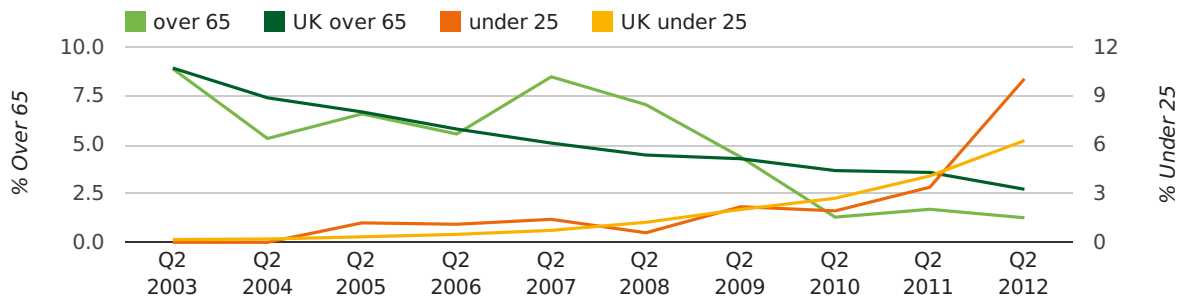

director age by quarter

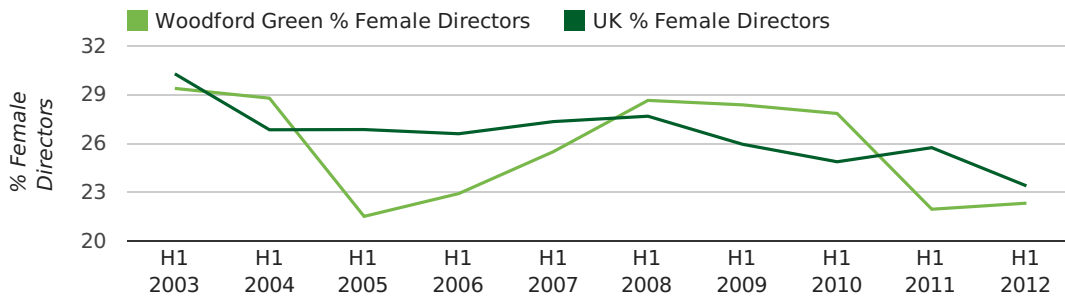


Half Year Data (Jan-Jun 2012)

The record first half year for female directors in Woodford Green was 1857 when 40.0% of all directors were female.

22.3% of all director appointments in Woodford Green in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

director gender by half year

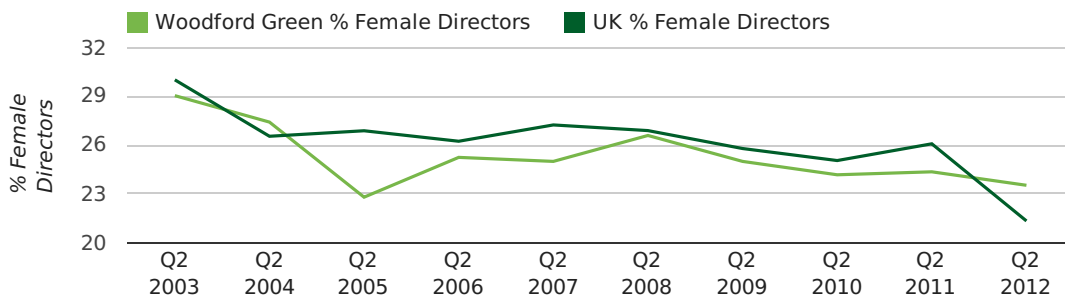


Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Woodford Green was in 1866 when 66.7% of all directors were female.

23.5% of all director appointments in Woodford Green in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
