




## Half Year Data (Jul-Dec 2011)




#### new companies by half year



# Half Year Data (Jul-Dec 2011)




A total of 139 companies were dissolved in Worcester during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 204 companies were added to the company register for Worcester in 2011. This number represents growth of 31.2% which compares unfavourably to the UK figure of 34.6%.




## Half Year Data (Jul-Dec 2011)




Net company growth for Worcester during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 34 companies.

#### net growth by quarter






company share by year







#### director age by year





#### director age by half year



#### director age by quarter





#### director gender by year




# Half Year Data (Jul-Dec 2011)
