




# Quarterly Data (Q2 Apr-Jun 2012)



#### dissolved companies by half year












company share by half year





#### director age by half year





The percentage of directors over the age of 65 was 5.8% compared to the UK figure of 3.3%.






The record first half year for female directors in Worcester was 1861 when 40.0% of all directors were female.

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2012)
