

In the first half of 2012 a total of 1,529 companies were formed in Worcestershire. This figure is 1.0% higher than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Worcestershire occurred in 2003 when a total of 1,573 were formed.

#### new companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

This figure is a decrease of 0.7% versus the same period last year (Q2 2011). This figure compares badly to the UK as a whole, which saw an increase of 8.3% against the same period last year.





#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 522 companies were dissolved in Worcestershire during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 20.6% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.



## net growth by half year





#### net growth by quarter









## director age by half year





The percentage of directors over the age of 65 was 4.7% compared to the UK figure of 3.3%.


#### director age by quarter
