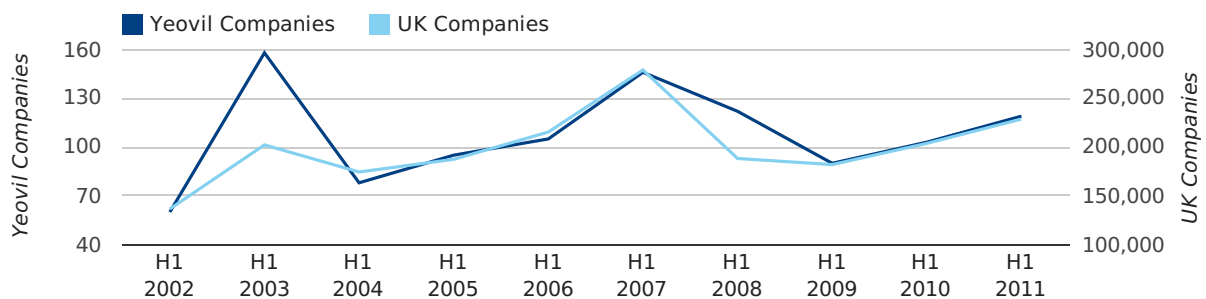
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 119 companies were formed in Yeovil. This figure is 15.5% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Yeovil occurred in 2003 when a total of 158 were formed.

new companies by half year



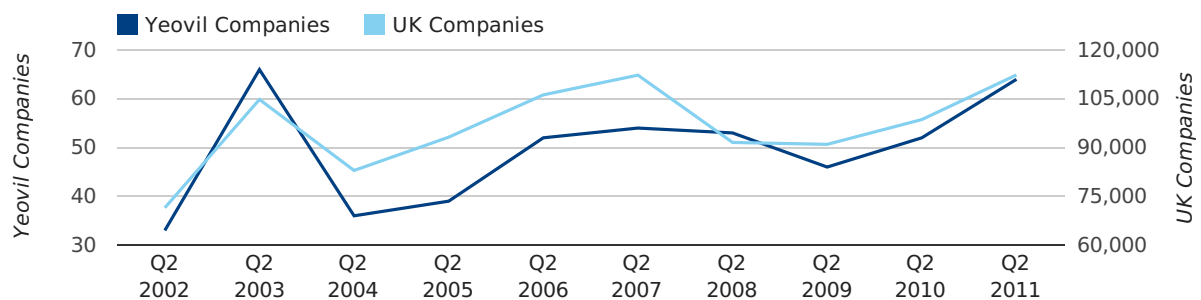
Quarterly Data (Q2 Apr-Jun 2011)

This figure is an increase of 23.1% versus the same period last year (Q2 2010). This figure compares well to the UK as a whole, which saw an increase of 13.9% against the same period last year.

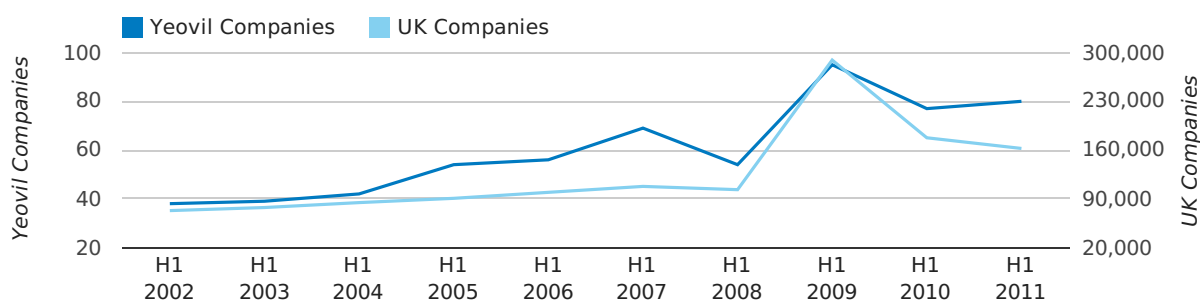
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 80 companies were dissolved in Yeovil. This figure is 3.9% higher than last year, which compares badly to the UK wide change of -8.6%.

The highest total for a first half year in Yeovil occurred in 2009 when a total of 95 were closed.

dissolved companies by half year



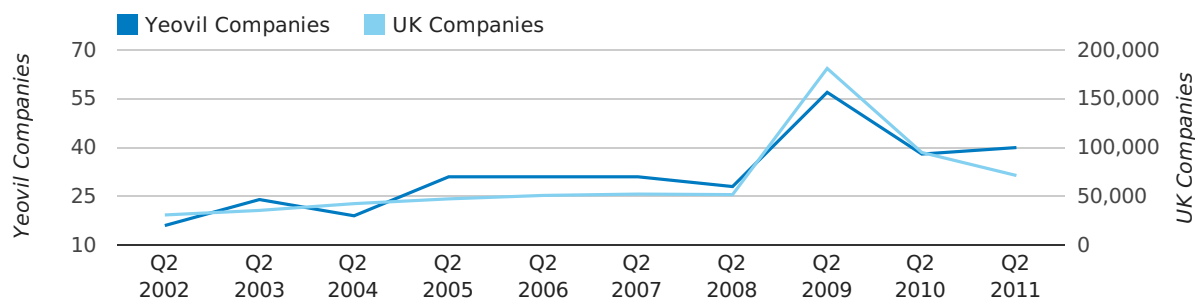
Quarterly Data (Q2 Apr-Jun 2011)

This figure is an increase of 5.3% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.

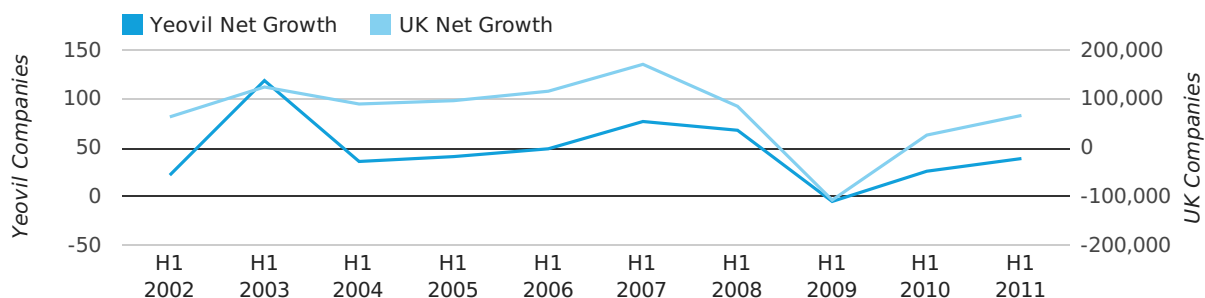

net growth by half year



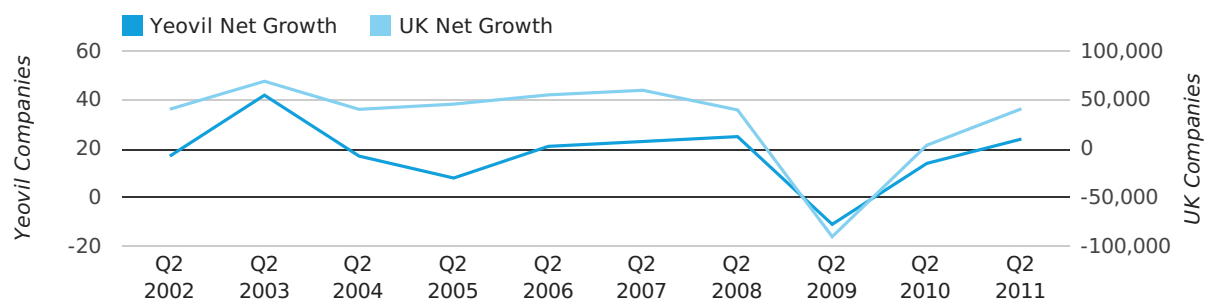
Quarterly Data (Q2 Apr-Jun 2011)

This represents an increase of 71.4% on the same period last year.

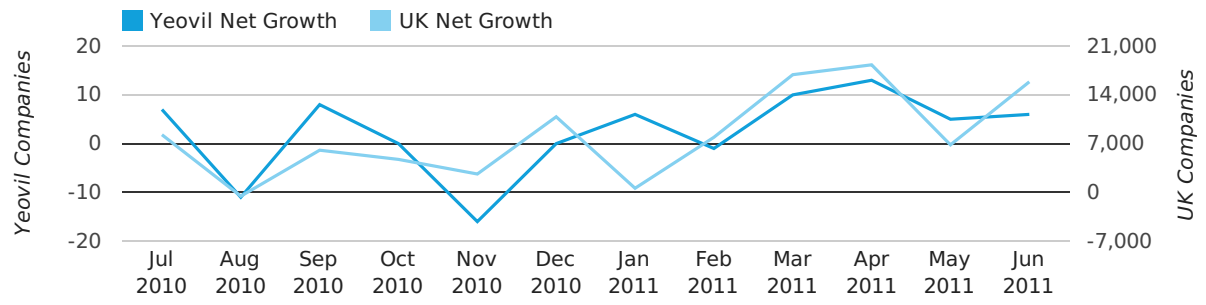

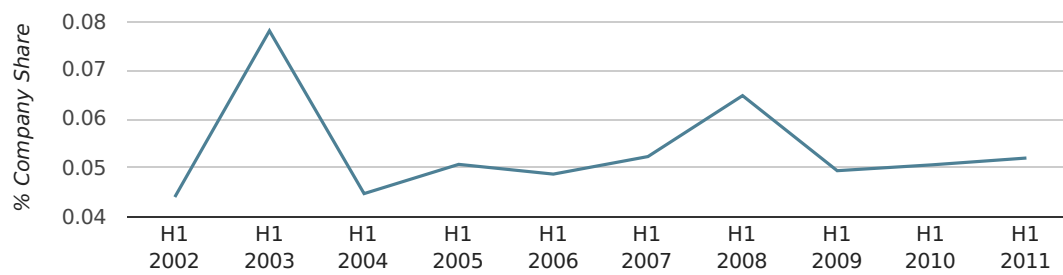

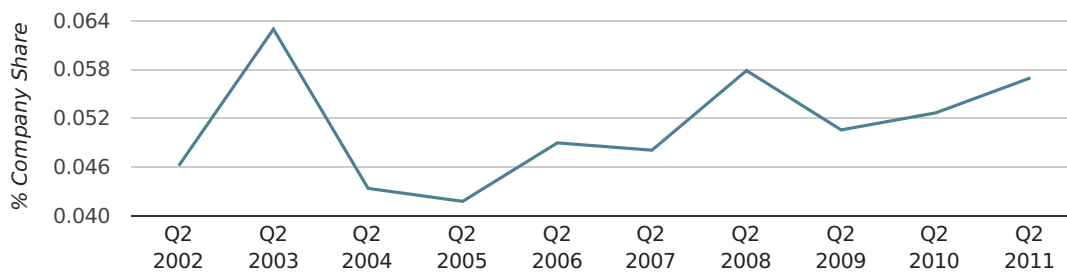

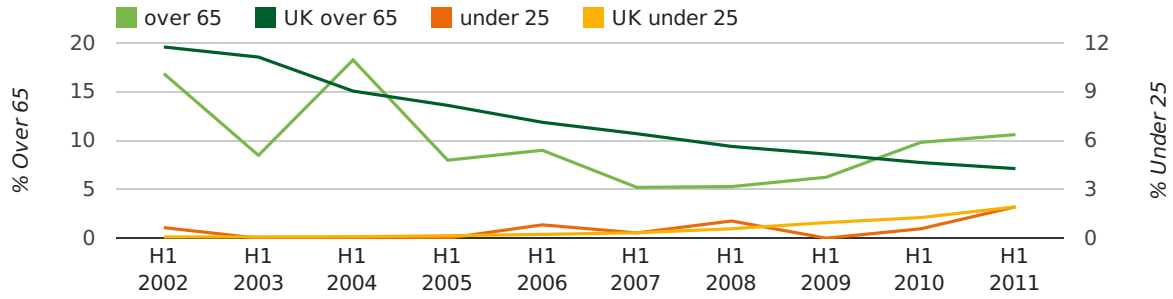

director age by half year



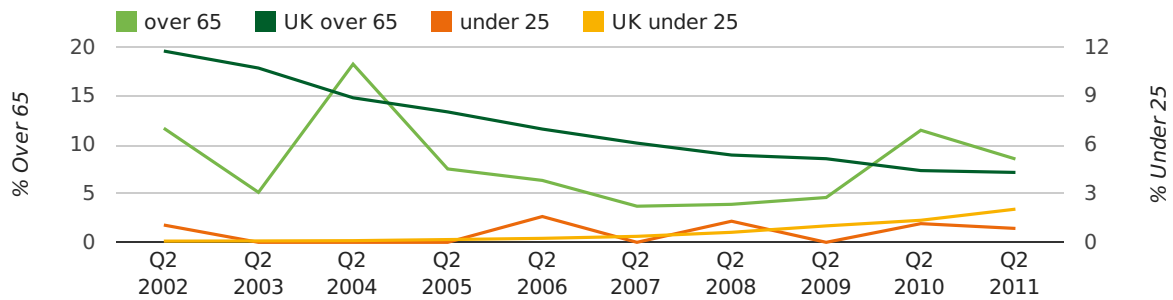
Quarterly Data (Q2 Apr-Jun 2011)

director age by quarter

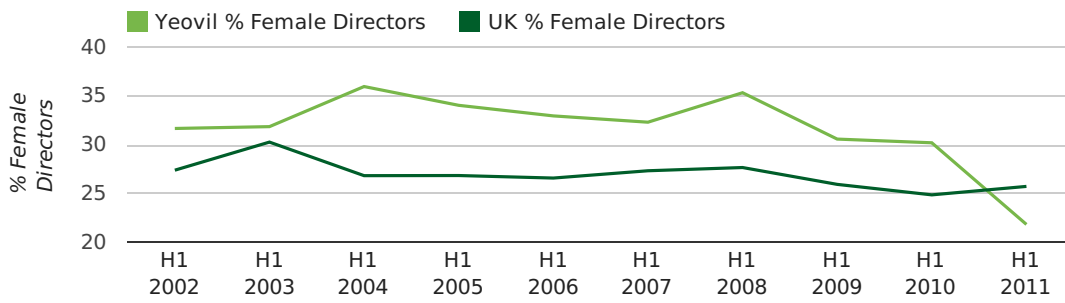


Half Year Data (Jan-Jun 2011)

21.8% of all director appointments in Yeovil in the first half of 2011 were female. This compares to a UK average of 25.7% for the same period.

director gender by half year

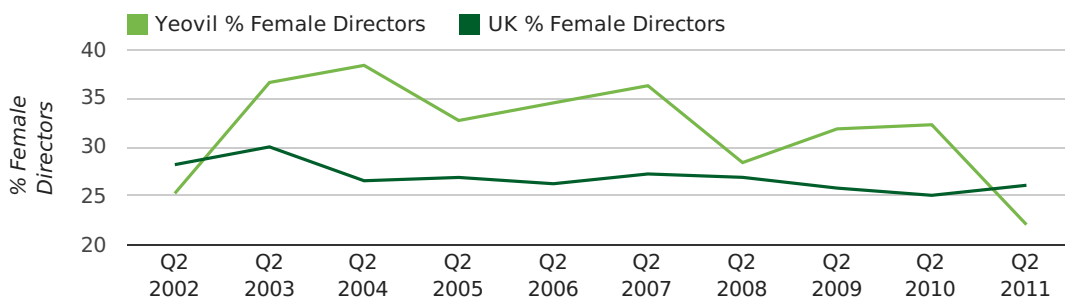


Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Yeovil was in 1866 when 66.7% of all directors were female.
