


The second half of 2011 saw a new record in company registrations in York when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in York when compared to any previous Q4.





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 230 companies were dissolved in York during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 524 companies were added to the company register for York in 2011. This number represents growth of 40.2% which compares favourably to the UK figure of 34.6%.




Half Year Data (Jul-Dec 2011)

net growth by half year










company share by half year





director age by year





director age by half year



director gender by year



director gender by half year


